Annual Fee

The increase to the MI annual renewal fee this year has been kept as low as possible. Apart from the other benefits, payment of the fee gives your staff and volunteers a discount for many MI activities, and provides access to reduced rates for [corporate travel insurance](#) and [long-term travel insurance](#). For the first time, the MI annual fee also includes a subscription as a Basic Partner of [Mission Seek](#). Please email mms@missionsinterlink.org.au to register your organisation with Mission Seek so you can upload your organisation's profile and list your vacancies and opportunities on its database. If your organisation is already registered as a Mission Seek Basic Partner, this will automatically be renewed with MI fee payment. Separate invoices will be sent to renew Full and Limited Mission Seek partners. Please note that work will be carried out over the next 6 months to enhance and promote the Mission Seek facility.

As membership fees cover less than half of Missions Interlink's annual costs, if you are able to, we invite you to add a donation to assist with support for the National Director and other staff.

Notes to assist in completing statistics and in calculating annual membership fees

Your membership level is based on the size of the organisation taking into account both personnel numbers (home and field staff) and an estimated donation income. Please indicate whichever level provides the **higher** result from the options provided in the following table:

Level	Member Fee	Explanation
M1	\$473	Up to 2 personnel or donation income less than \$200,000 <i>(Includes Accreditation fee of \$187)</i>
M2	\$748	3-5 personnel or donation income between \$200,000 and \$500,000 <i>(Includes Accreditation fee of \$275)</i>
M3	\$979	6-9 personnel or donation income between \$500,000 and \$1,000,000 <i>(Includes Accreditation fee of \$330)</i>
M4	\$1,177	10-24 personnel or donation income between \$1,000,000 and \$2,500,000 <i>(Includes Accreditation fee of \$330)</i>
M5	\$1,606	25-49 personnel or donation income between \$2,500,000 and \$5,000,000 <i>(Includes Accreditation fee of \$363)</i>
M6	\$2,035	50 or more personnel or donation income above \$5,000,000 <i>(Includes Accreditation fee of \$374)</i>
MB	\$473	All Bible colleges and missionary training institutions <i>(Includes Accreditation fee of \$187)</i>
